Location & Description:

This development of 108 housing units and 3 Commercial Units, is located west of Kilkenny City and within its development boundary as defined in the Kilkenny City and Environs Development Plan 2014-2020. It is accessed from the Callan Road, just under 1Km from the Callan Road Roundabout and opposite the Seville Lodge complex.

Planning History:

P04 / 798:

Residential Units 1-76, Seville Lawns together with 3 Commercial units , were built on foot of this permission. The internal road network within Seville Lawns has been transferred from the Developer to the Margaretsfield Management Company and does not form part of this Taking in Charge Report.

P06 / 1089:

Residential Units 1-32, Seville Grove were built on foot of this permission.

TIC Request

An application relating to the Taking in Charge of Margaret's Field's, Callan Road, Kilkenny was submitted by the developer on 31st July 2009

Recommendation:

The service departments of Kilkenny County Council are satisfied to proceed with the taking in charge of this development, and Irish Water has been notified accordingly. Therefore, I recommend that:


