Site Location & Description

Mallfield is a residential development located in the townland of Grennan in Thomastown, The development contains 98 houses in total with the house types being two storey detached, semidetached and terrace houses. The development is accessed from Castle Avenue (LS-8210) via a single access / egress point.

Planning History

P00/1195 – Permission for the construction of 12 no. townhouses, 18 no. semi-detached and 6 no. 2 storey houses at Grennan, Thomastown. Granted by Kilkenny County Council subject to 31 conditions on 23rd April 2001.

P01/1114 - Permission to amend P00/1195 and reduce the number of houses by 2. Granted by Kilkenny County Council subject to 31 conditions on 16th October 2001.

P02/1058 – Permission to construct a further 34 dwellings and associated works. Granted by Kilkenny County Council subject to 35 conditions on 6th January 2003.

P04/1381 – Permission to construct a further 32 dwellings and associated works. Granted by Kilkenny County Council subject to 34 conditions on 21st September 2005.

TIC Request:

The formal request to have this development taken in charge was made in writing by the developer on 12th March 2009. The developer engaged with the Planning Authority in completing some of the remaining works but the developer's access to funding ceased and the Company is now in receivership, Kilkenny County Council made a claim on the bond which was in place for the development. The remaining works were substantially completed in quarter 1 of 2017. The costs incurred by Kilkenny County Council will be claimed from the special liquidator.

Recommendation:


