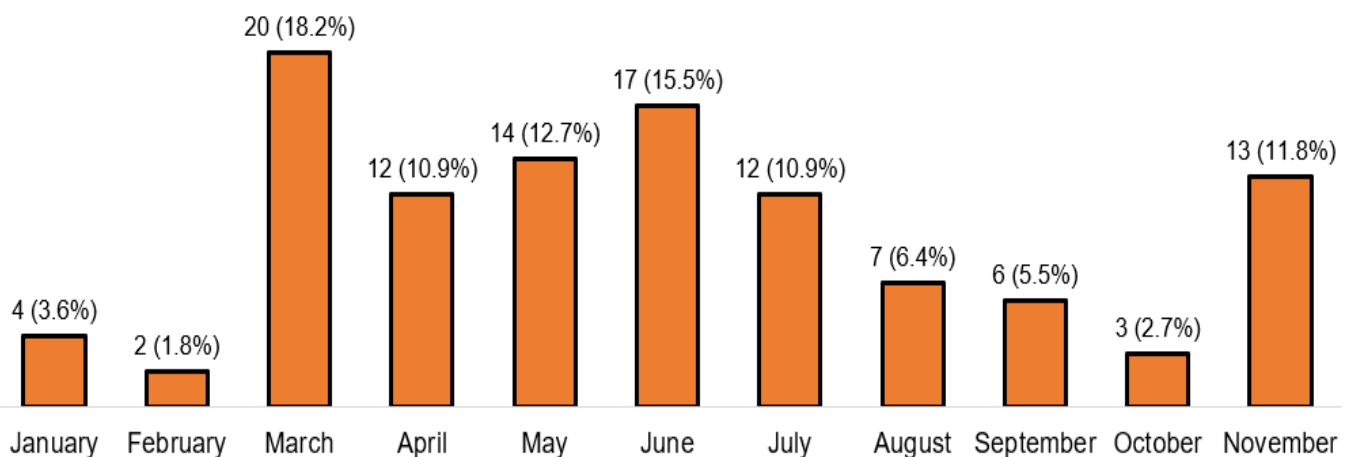

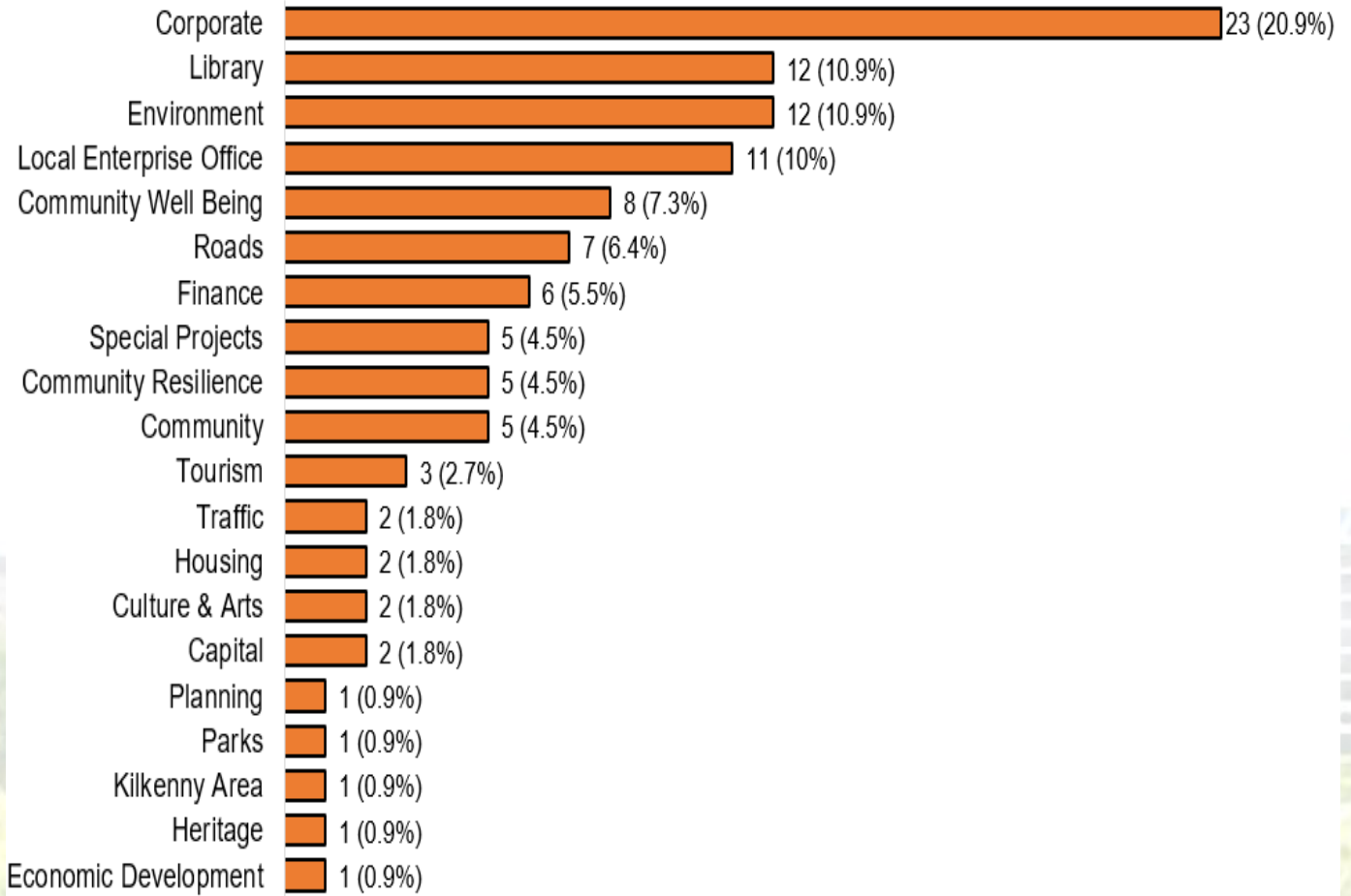




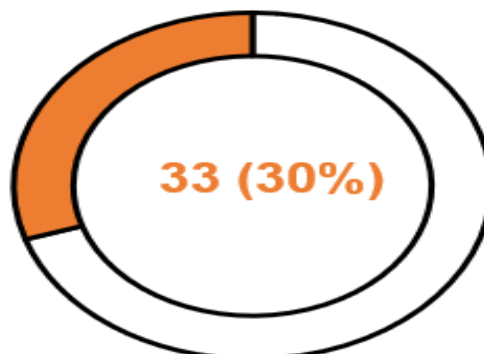

## CORPORATE

### YULEFEST KILKENNY

Yulefest Kilkenny was launched by the Cathaoirleach on Saturday 28<sup>th</sup> November from the Santa Villiage in the Medieval Mile Museum. This was a virtual launch and was live streamed on Yulefest social media channels. The Mayor of Kilkenny followed the event by switching on the lights in Kilkenny City at the Parade which was also live streamed across our social media channels.



The focus this year will be on virtual or online events. Here are some snippets of what will be happening in and around Kilkenny during the festive season:

- Christmas Markets will be taking place on the Parade in compliance with social distancing guidelines.
- A socially distanced Santa's Christmas Village will run in the grounds of the Medieval Mile Museum.
- Listen to messages from Santa online on yulefestkilkenny.ie and on social media.
- Festival in a Van will visit Nursing Homes on the weekend of 19<sup>th</sup> and 20<sup>th</sup> December supported by Creative Ireland.
- "Christmas at Butler Gallery" includes a virtual tour of Wolfwalkers Exhibition and online Christmas Children's Art Workshop.

- "Garden of Light" symbolising hope for 2021 and remembering those we have lost in 2020 is located in the grounds of Kilkenny Design and Crafts Centre.



## ROADS

### ROADWORKS PROGRAMME 2020

The majority of the works are now complete on Non National roads. Approximately €16.7 million has been spent on the upkeep of the network and local improvements around the City and County in 2020.

The works include:

**Road Restoration (Blacktop)** - €7.85 million expended on 83 projects surfacing 79km of local and regional roads.

**Surface Dressing (Tar & Chip)** - €2.26 million on 82 projects surface dressing 101km of local and regional roads.

**Discretionary Works** - €2.65 million discretionary works allow the Municipal District undertake specific maintenance and improvement works. In total 75 projects including footpath repairs, footpath extensions, additional public lighting, improvements in villages etc.

**Drainage Works** - €652k on 55 projects assisting with the elimination of localised flooding issues.

**Low Cost Accident Schemes** - €368k spent on 14 schemes providing road safety works at specific locations throughout the county.

**Bridge Rehabilitation** - €200k on 11 bridges.

**Surfacing Public Lanes** (*Community Involvement Scheme*) - €729k surfacing 14 lanes.

**Surfacing Private Lanes** (*Local Improvement Schemes*) - €291k surfacing 6 lanes.

## NATIONAL ROADS

### Pavement Schemes

#### **N76 Callan By-Pass to Ballymack & Cuffesgrange Pavement Project**

A major pavement project involving improvement to 5.05km including drainage improvements, road markings, etc. has been completed on the N76.

### **Kilkenny Minor Schemes**

A number of minor schemes are progressing through various stages in conjunction with TII on the national road network.

#### **N24 Tower Road**

Planning approval for the proposed scheme was secured in 2019. Approval of the Compulsory Purchase Order for the scheme was given by An Bord Pleanála on the 5<sup>th</sup> August, 2020. We are presently undertaking the administrative procedures necessary to give effect to that decision. It is expected that construction will commence in 2021.

#### **N77 Ballyragget to Ballynaslee**

A planning application under 177AE and a Compulsory Purchase Order application has been submitted to An Bord Pleanála in December for the above project.

#### **N24 Carrick Road**

The section of N24 proposed to be improved is rural in nature and located immediately North West of the village of Mooncoin in County Kilkenny. We are currently preparing the necessary documentation to make a simultaneous planning application to An Bord Pleanála for approval under 177AE along with a Compulsory Purchase Order for the scheme. It is expected that the application will be made towards the early part of Q1 2021.

### **Kilkenny Major Schemes**

#### **N25 Glenmore to Waterford Scheme**

The scheme is within the concluding stage of Phase 2 - Option Selection. A preferred route corridor is expected to be announced in early Q1 2021.

#### **N24 Waterford to Cahir Scheme**

Arup and Partners Ireland Ltd are working in the early design and feasibility stages of this project which will take approximately 60 months. Their brief is to bring the scheme through the statutory processes. (*Planning, CPO, etc.*)

### **Other Projects**

#### **Kilkenny Western Environs Phase 1 Infrastructure**

Construction of the scheme commenced on 4<sup>th</sup> March, 2019 and site works remain ongoing. The traffic management measures necessary to construct the new roundabout at the junction of the scheme with the N76 Callan Road were lifted on Friday November 13<sup>th</sup>, following completion of the works at this location. The Circular Road remains closed to facilitate upgrading of the existing road and the construction of new bridges over the River Breaghagh. These works are

scheduled to be completed before Christmas 2020, thereby allowing the Circular Road to reopen to traffic in advance of the full scheme completion. The project is expected to be completed in March 2021.

#### Castlecomer Footbridge

The preparation of construction tender documents is on-going with a view to going to tender in December 2020 or early Q1 2021. The main construction works will take place during the summer 2021 with works to be completed by Q4 2021.

**Vacant Sites**

Section 7.1 notices were served on a total of 9 sites in November. These notices alert landowners that their sites are being considered for addition to the Register for 2021. The landowners now have an opportunity to make a submission to the Council, outlining any reason as to why their sites should not be entered on the Register.

There are currently 30 sites on the Vacant Sites Register. A total of 19 of these are now liable for the 7% levy. The Council were in the process of issuing payment demands in March, however that process was halted following the Government's Emergency Order. The process will recommence to ensure compliance with statutory deadlines. Two sites have had their levy discharged to date.

The number of cancelled entries due to site activation or improvement now stands at 13 sites.

**PARKS**

**Parks & Playgrounds**

Annual inspections for all 31 playgrounds in the charge of the Parks Department are now underway. This is an independent inspection of all playgrounds by an inspector registered with the RPII (Register of Play Inspectors International). Each playground must pass the inspection to be considered fit for play and use for the coming year. Any maintenance or repair issues identified during this process will form part of the schedule of works to playgrounds in the coming year. All works to playgrounds for

2020 are now complete maintaining playgrounds to a high standard,

Works will commence on Piltown playground in January. The site, located to the rear of the old Garda Station, Main Street Piltown is an attractive riverside location with mature vegetation. The playground will be developed by the local community with assistance from the Parks Department and funding from the Community and Cultural Capital Facilities Scheme.

Tree planting is taking place currently in the Fairgreen, Callan to complement other recent works to the area.

### **South East Greenway**

The project received a welcome boost in mid-November with the announcement that €15.5 million, the current estimated cost of the project, will be provided towards the construction costs under the national Greenway Fund in 2021 and 2022. The increase in the grant aid recognises the challenges faced by Local Authorities nationally during the Covid crisis in finding the matched funding for significant capital projects. The increased funding will allow the project to be delivered and open for use in 2022.

Works are now completed on the rail lifting contract on the South East Greenway which runs from Ferrybank in South Kilkenny to New Ross, terminating at Mount Elliot. Rails and sleepers have now been lifted and the contractor will be pulling off site shortly having completed the final clean up.

In the urban section of the Greenway in the Ferrybank area, screen fencing is currently being

erected to address concerns over security and privacy due to the proximity of the old railway line to back gardens, in particular in the Ard Glas area.

The clearance of the track and lifting of rails will clear the way for construction of the Greenway which is anticipated to commence in 2021. The urban sections of the route in Ferrybank and Rosbercon have now been tendered as it is planned that the 24km route will be delivered in a number of sections.

Two Part 8 planning applications for Greenway Car Parks to facilitate access to the Greenway at Raheen, New Ross, Ballyverneen, Glenmore and Ferrybank have now been approved by the Council. A public consultation process is underway to inform local residents from the Ferrybank area of the Council's intention to develop a car park in the Ferrybank area to serve the Greenway. As part of this process there will be an online meeting with those residents who wish to be involved. As part of this process the Council is also keen to highlight the need to develop links from surrounding residential areas to increase permeability and accessibility to the greenway for local users.

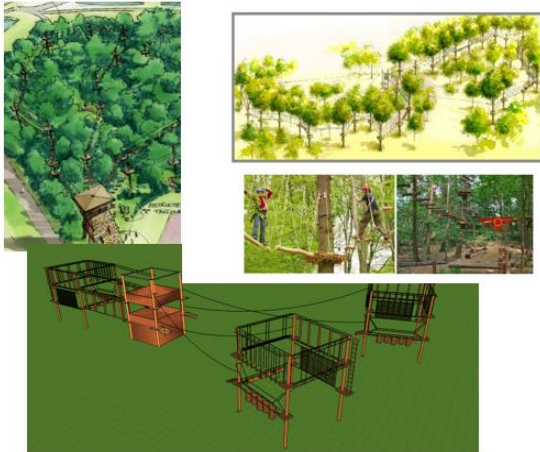

As advised in the November's Chief Executive Report, 7 applications were submitted under Measure 1 at the end of September 2020.

The deadline for the submission of Measure 2 & 3 applications was the 30<sup>th</sup> November and the following projects were put forward in order of priority:



**Woodstock Gardens**

The installation of some festive themed props is underway in the gardens to celebrate Yulefest which this year will be a more socially distanced affair. An elf themed trail and some festive deer



can be found in the gardens. The conservatory mural by Gillian Campden is now practically complete and a Christmas tree has been erected to bring some extra festive cheer.

**Christmas Stars for Woodstock Gardens**



As part of the Community Resilience campaign 'Keep Well' the Arts Office has organised for an installation of 3D Christmas Stars to be displayed in Woodstock Gardens as part of Yulefest 2020. The Stars are being painted by local primary school children at St. Colmcille's National School, Inistioge and St. Marys National School, Thomastown.

The school children are delighted to take part in the decorating of the Stars and very excited to see them on display at Woodstock with their families. There will be a total of 15 Stars arriving at the gardens on 21<sup>st</sup> December.

The gardens will be open right through the Christmas period with the exception of Christmas day. The coffee van will be available offering hot refreshments subject to weather.

An ORIS application has been made to the Department of Rural and Community Development to continue the Woodstock estate walks further downstream towards the Brownsford Stream and Waterfall, returning to Woodstock via the 'American Road' which was once the way emigrants leaving Ireland for the last time travelled for the boats to the US. The waterfall is a stunning feature in Woodstock which is little known as it is tucked deep into the woods.

### Amenity Grants

166 groups were awarded a grant based on a number of criteria for example size of estate, small or large village or town with grants ranging from €454 to € 2,270 in 2020. The Parks Department administers the scheme, which is available to voluntary community organisations from all over the County. The main objective of the scheme is to encourage and aid small-scale works to improve the local environment and encourage community involvement in the upkeep and maintenance of public amenities. In 2021, there will be an increased focus on supporting pollinators through projects which are funded. Community groups will be encouraged to manage amenities in a more sustainable manner

in line with the pollinator plan which the Council has adopted. Grants are now being drawn down by the community groups with over 95% of the grants paid out to date.

### ENVIRONMENT

#### Kilkenny Biodiversity & Recreational Countryside Park



This is an extremely exciting project for Kilkenny, to repurpose the closed 17-acre old landfill site at Dunmore into a high-quality amenity. The overall ambition is to develop a parkland that will create a regional destination for health and wellbeing, attracting fitness and outdoor enthusiasts of all abilities, nature lovers and educational providers. Another key objective of the proposal is to create connectivity back into the City along the River Nore Linear Park leading onto the Nore Valley walking trail, creating a key element in the Kilkenny City and Environs Green Infrastructure offering.

In November, significant project milestones were reached to bring this proposal closer to a reality. A funding application under Measure 3 of the Outdoor Recreational Infrastructure Scheme was submitted to the Department of Rural and Community Development. The maximum grant available under Measure 3 is €500,000, and the maximum amount was applied for under the application.

Planning for the project is being sought under Part 8 and the documentation for same was finalised and a planning application submitted to the Planning Section. Under this process the proposal will go out to public consultation from the 11<sup>th</sup> December 2020 until the 22<sup>nd</sup> January 2021 and submissions/ observations relating to same can

be submitted up to the 5<sup>th</sup> February 2021. Thereafter, it is intended that a Planning Report will be prepared and presented to the Elected Members for the February Council Meeting.



### Environmental Complaints

The number of complaints logged and investigated by the Environment staff this year to date has seen a 34% increase on the same period last year with 1,250 complaints investigated compared with 1,024 for last year. There has also been a 34% increase on the number of complaints since Covid 19 restrictions were introduced in March.

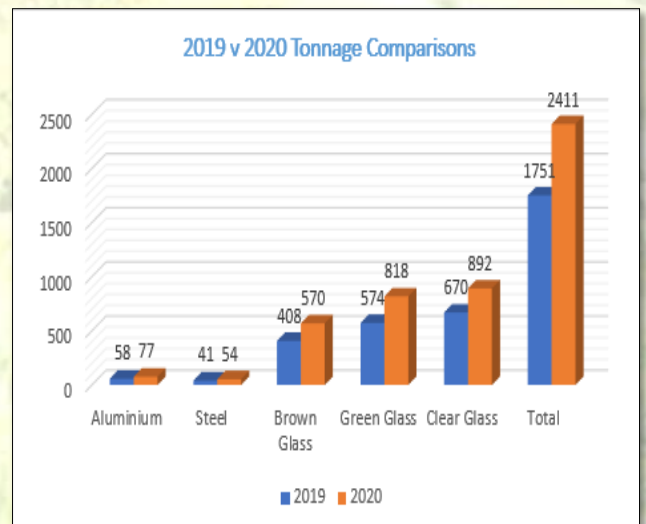
The nature of these complaints range from littering, illegal dumping, water quality, noise, abandoned cars and odours from controlled and illegal burning and farm activity. However, the majority continue to be related to littering and illegal dumping.

Environment staff are continuing to work very closely with our Service Providers to ensure the level of service is in keeping with the demand with a particular focus on the upcoming Christmas period when demand is likely to increase even further. This is however particularly challenging as the main service provider is also contracted to a number of other Local Authorities who are also experiencing a similar trend.

Despite the restrictions imposed due to Covid 19, the Enforcement Team remains very active with 223 litter fines issued this year to date.

### Bring Banks

The 46 Bring Banks managed by the Council across the city and county have seen a massive increase in usage when compared to previous years. From the tonnage collection data, it is clear to see that usage increased in line with the introduction of the Covid-19 restrictions back in Mid-March and have remained at an increased level in the intervening period. 2,411 tonnes were collected from the 1<sup>st</sup> January to the 7<sup>th</sup> December in 2020 compared to 1,751 tonnes for the same period last year. This equates to a 38% increase for the 11 months amounting to 660 tonnes of extra material for recycling. The bring bank at the Newpark Shopping Centre recorded the highest usage with 148 tonnes collected whilst Ballyouskill had the lowest usage with 6.2 tonnes. Other bring bank collection rates across the county include, Urlingford 55 tonnes, Gowran 41 tonnes, Lidi Loughboy 143 tonnes, Mooncoin 99 tonnes, Mullinavat 56 tonnes Graiguenamanagh 114 tonnes Thomastown Lidi 110 tonnes, Callan 83 tonnes, Ferrybank Aldi 88 tonnes, Slieverue 36 tonnes, The Rower 16 tonnes, Goresbridge 28 tonnes and Ballyragget 38 tonnes.

### Recommended Minimum Criteria Environmental Inspection (RMCEI) Plan -2020

The restrictions put in place to combat the spread of Covid 19 has impacted on planned inspections that required site visits and/or meetings with landowners. However, notwithstanding this the only target not to be met this year involved inspections with other state agencies which could not take place due to Covid. Thanks to the efforts of our Enforcement Team, all our targets under the National Priorities have been reached.

The campaign launch took place during waste week and will continue into 2021. The launch was marked by a media promotion on BEAT FM and a furniture up-cycler Marianne "The Revamp Tramp" was a campaign ambassador and promoted the ten tips on her social media platforms. The campaign consists of an information leaflet, stickers for paint tins, a film and social media posts which are currently being advertised in the Kilkenny Credit Unions. occur and should regional DIY shows recommence, the campaign will be promoted at these types of events. The "Paint Smarter" campaign is a Local Authority Prevention Programme initiative funded by the National Waste Prevention Programme, an EPA led Government of Ireland Initiative.

### Litter Management Plan 2021-2023

The current Litter Management Plan is under review as the plan period runs until the end of 2020. A new plan is currently being drafted and will be put out to public consultation in spring next year. Before the public consultation phase commences, the draft plan will be circulated to Elected Members and presented at each Municipal District as Elected Members suggestions and ideas on how Kilkenny can combat litter will be gratefully appreciated. The draft plan will go on public consultation and the Environment Section will seek input from different groups like the tidy towns forum, the PPN and other voluntary bodies and it will be presented at SPC4 before the final version goes for adoption at a Council meeting. Your input into this policy document would be appreciated as it sets out priorities, targets for litter management over the next three years.

### Christmas Trees Collections 2021

Plans are currently being prepared to accommodate Christmas tree drop off locations for householders early in the New Year. This allows trees to be chipped and composted after the festive season. The collection period will run between the 4<sup>th</sup> and 18<sup>th</sup> January at the following locations.

### Air Quality Advertisement

The Environment Section recently published a picture advertisement in the Kilkenny People. The publishing of the advertisement was on behalf of the Department of Environment, Climate and Communications. The advertisement is designed to encourage the use of low smoke and smokeless fuels to heat for home heating. The message is very timely with the recent reports of declining air quality across the country, particularly on the last weekend of November 2020 where air quality was the poorest it has been in 30 years in some towns and cities. The main particulate exceedances was PM<sub>2.5</sub>, which is mainly from solid fuel burning.



To build on above, early in the new year the Environment Section will run an air quality and solid fuel awareness campaign. Information on how to heat your home in a more environmentally friendly and sustainable manner, which in turn will improve air quality, will be distributed through print and across the various social media platforms.

### Climate Action - Woodland Creation Scheme

Under the 2020 Programme for Government, the Climate Action Regional Offices have been tasked to work with public bodies to review land availability for planting, feedback on the potential in this area, is required to be submitted by the end of 2020. This initiative is being progressed in

partnership with the CARO's, the Department of Agriculture, Food & the Marine (DAFM) and those Local Authorities who have expressed an interest in advancing same.

Kilkenny County Council is very keen to be involved in this initiative and the Environment Section identified 17 potential sites through a desk top survey for consideration under the Woodland Creation Scheme. A Working Group comprising of various members across the organisation was formed to review the suitability of the lands identified. In total 10 sites identified were deemed unsuitable for further consideration for a variety of reasons, such as:

- Potential future use for housing development;
- Existing community use, such as sporting amenity;
- Potential future use for wastewater or water services expansion;
- Proximity of neighbours and requirements for set back from existing houses.

The Environment Section has arranged for the remaining 7 sites to be inspected by Teagasc in December 2020. Following guidance from Teagasc, consideration will be given to their use under Woodland Creation Scheme.

#### **Climate Alliance - taking local action on global climate change**

Kilkenny County Council has recently joined the European Climate Alliance. Kilkenny, Carlow and Wexford local authorities are the first in Ireland to join. The Climate Alliance is a pioneer in global and local climate protection, with long-established traditions of collaboration with indigenous peoples as well as specific CO<sub>2</sub> reduction goals, to which each member municipality commits itself. Since their foundation 30 years ago their network has grown to over 1,700 members in 26 European countries.

Being a Climate Alliance member means being part of a city network dedicated to climate action,

teaming with like-minded local authorities. Opportunities to inspire and be inspired abound.

#### **Energy Management - ISO50001**

Kilkenny County Council is currently pursuing ISO 50001 Energy Management certification to continue with the energy efficiency improvement trends. This certification will put in place a robust energy management system to manage energy consumption and the performance of significant energy users and realise energy saving and carbon reduction targets up to 2030 and beyond. Stage 1 of the certification process has taken place late November with stage 2 scheduled for mid-January.

### COMMUNITY

#### **Pride of Place 2020**

Castlecomer Discovery Park, Clogh Village, the Callan Town Team and Kilkenny County Council were honoured at the all-Ireland Pride of Place Community Awards on the 21<sup>st</sup> November, 2020. The Castlecomer Discovery Park took top spot in the Community Tourism category with Judges praising them for delivering a "tourism enterprise par excellence". Callan Town Team were runners up in the Areas with a population between 2,000 and 5,000 and Clogh Community Group in the population between 300 and 1000 category.

Kilkenny County Council was awarded the Council Community Engagement Award for their ongoing work on community engagement.

#### **Rural Regeneration Funding Application 2020 (DRCD)**

An application for funding under the Rural Regeneration Fund was submitted to develop a new Library and Community Facility (€2.7m) in Thomastown.

#### **"Keep Well" Campaign**

Kilkenny County Council submitted its plan under the Community Resilience Fund. The plan covers actions under the "Your County",

## Comhairle na nÓg

Kilkenny have received a grant of €3,000 for ICT equipment to support Comhairle na nÓg members to take part virtually while complying with COVID guidelines.

## CYPSC

Kilkenny CYPSC has been allocated €18,500 under the Keep Well National Resilience Strategy. The funds will be used for Youth friendly mental health initiatives throughout the county.

### Creativity & Culture in Yulefest

Funding from Creative Ireland, under the Kilkenny Culture & Creativity Strategy, was secured to promote a strong heritage and creativity element in this year's Yulefest programme, including Festival in a Van; Guess the traditional shopfront; My Heritage selfie competition etc. This year's focus is on shopping local, exploring Kilkenny's wonderful outdoor sites, and being creative.

### Talbots Tower Park to Re-open to the Public

The conservation and repair works to the roof at Talbots Tower are completed and the park at Talbots Tower will re-open again to the public shortly. The works to the medieval tower were co-funded by the Irish Walled Towns Network and Kilkenny County Council.

In the past few months many people as a result of the pandemic are now remote workers based in the South East.

The South East Local Authorities and their Local Enterprise Offices ([www.localenterprise.ie](http://www.localenterprise.ie)) in association with SEBIC / Ireland South East Office are undertaking research to assess the current demand for remote working in the South East as well as the range of services and assistance required to support remote working in hubs across the region. The survey takes just a couple of minutes and one of five prizes of €100 can be won for a restaurant in either Carlow, Wexford, Waterford, Tipperary & Kilkenny.

#### Initiative Launched to Encourage “Shop Kilkenny – Keep It Local – Shop Safely”

A new initiative has been launched by Kilkenny County Council to highlight the importance of small business right across the County and encourage people to support them in the run up to Christmas. The Campaign “Shop Kilkenny-Keep it Local – Shop Safely” is designed to raise awareness of the many small business across our County towns and village and remind shoppers that where we direct our spending shapes the future of where we live.



#### LEO CLIENT STIMULUS FUND SCHEME

Under the July stimulus, a €10m. fund was ringfenced for Local Enterprise Office clients. This fund is available to enable these businesses to move into a recovery phase.

The purpose of the Local Enterprise Office Client Stimulus Scheme is to sustain eligible businesses through the provision of a cash stimulus to support operational costs and enhanced engagement with their Local Enterprise Office. The funding will be through an immediate cash contribution to support liquidity and could be used to cover ongoing operational costs, for example, utilities, insurance, refurbishment or for measures to ensure employee and customer safety.

The funding is conditional upon eligible businesses agreeing to complete a project focused on driving key themes such as Competitiveness both Operationally and Green, Capability across Leadership, Innovation, Strategic Finance and New Market Development which will support the mitigation of the effects of the Covid and Brexit crises. These projects will be funded through the Local Enterprise Office 2021 budget.

The intention is that the funding and associated projects will provide businesses with a platform from which they can sustain and grow thereby contributing to the recovery of the Irish economy.

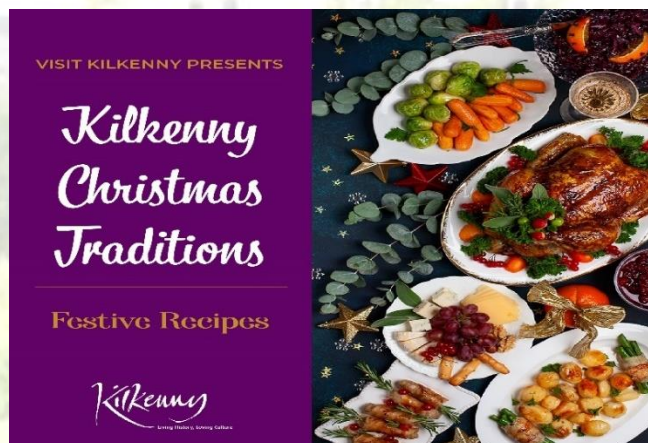
## Visit Kilkenny.ie & Kilkenny Tourism

## ARTS

### Winter Poetry Online

We commenced our 6-week online poetry course, with lecturer, poet and author Dr Derek Coyle, on Thursday 12<sup>th</sup> November and it will finish on 17<sup>th</sup> December. All participants had to submit a poem a week to the course tutor and aim to build up and enhance their poetry portfolio with the ambition of submitting work to competitions, magazines and online journals with the long-term ambition of completing a collection. Participants explored poetic forms, learned about prose poetry, satire, the dramatic monologue, metaphor, simile and symbol. Feedback from our participants so far has been excellent.

### Rhyme Rag Ensemble

On Saturday 14<sup>th</sup> November the Rhyme Rag Ensemble attended a workshop with Beau

Williams. Beau Williams is an American poet, workshop facilitator, and spoken word artist based in Dublin. He engaged the young poets with free-writing, what makes good imagery in a poem: incorporating the 5 senses, using metaphor and simile. Overall Beau found them to be a very strong group of writers - eager to learn.

## FIRE SERVICE

### Capital Projects

The delivery of a new fire engine for Callan took place during the end of November.

### Fire Safety Certificates

109 applications for fire safety certificates were received up to 30<sup>th</sup> November 2020. This was a 19% increase in 2019 applications for the same period last year. These applications are administered by staff working from home and from our Headquarter station due to Covid-19.

### Fire Services Acts 1981 & 2003

To date Fire Prevention staff have made 41 inspections of premises both to provide advice and to enforce legislation. As of 30<sup>th</sup> November 2020, 87 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 & 2003.

### Community Fire Safety

Home fire safety visits have recommenced after Level 5 Lockdown. The aim of the home fire safety visits is to reduce the risk of fire by raising awareness to the dangers of fire, providing the appropriate advice and where necessary, fitting smoke alarms. As we head towards Christmas we have Smokey the Elf tweeting fire safety advice. Radio Interviews on fire safety were also given and an advert on fire safety Tips for Christmas have been placed on the local paper.

### Fire Brigade Operations

Fire Brigades responded to 726 turnouts up to the 18<sup>th</sup> November 2020. The same period last year we responded to 686 turnouts.

We were delighted to be involved in National Science Week again, as part of Kilkenny Science Festival, in collaboration with Calmast, WIT. We transformed our science week activities to new digital, virtual and outreach events - 8 schools enjoyed Slime workshops, 15 ASD units enjoyed bubbles workshops, 100 Volcano experiments were delivered to Newpark Family Resource Centre and 3 Childcare facilities, and 100 packs of bulbs were delivered to cocooners across the county.

### **Mobile Library Back on the Road**

Our mobile library has commenced service to over 20 primary schools across the county.

So far, over 3,000 books have been delivered to schools. Significant investment has been made in reading resources and literacy stock suitable for all ages.



### **School Resources: Class Book Sets**

We invested €8,000 recently in 750 new books to update our Class reader collection. 30 sets of 25 new books were purchased. These are suitable for a range of ages and reading abilities, and are now available for borrowing for 3 month periods by schools all over Kilkenny.

## FINANCE

The expenditure by service division to the end of November is set out in table 1. Total Expenditure for the eleven months to the end of November was €95.8m compared with the annual budget of €83.6m. The expenditure under development management includes a sum of €11.3m relating to the restart grants. This expenditure was not included in the budget but is fully funded by the Department of Business, Enterprise and innovation.

The bank overdraft facility was utilised six times during the eleven month period to the end of November 2020. The earlier payment by Government Departments of grant monies including the Local Property Tax allocation has assisted cashflow since the beginning of the Covid-19 crisis.

The audit of the 2019 Annual Financial Statements has been completed. The audited statements will be presented to Council at the December Council meeting.

### Rates Revaluation

The Valuation Office conducted a revaluation of all commercial properties throughout County Kilkenny to come into effect in the year 2018 as part of its ongoing programme to revalue all such properties within the State.

The following is an update on appeal outcomes and outstanding appeals:

- 197 Rate Customers appealed their valuation to the Valuation Tribunal.
- Total value of rate demand under appeal is €4.5m, 22.6%.
- 168 appeals have been completed to date (29 withdrawn).
- 134 of the 165 appeals have resulted in a reduction in rates income, 4 confirmed the decision of the revaluation, 1 resulted in an increase in rates income & 29 were withdrawn.
- Income lost to date = €778,112.
- 29 appeals outstanding.

If this trend continues the total loss will be in the region of €1m.

**Impact of covid-19 on Council Finances.**

As previously advised to Council, Covid-19 is presenting serious financial challenges as all income streams have been impacted.

An application for compensation for loss of income on Goods & Services and additional costs incurred due to Covid was submitted on Friday December 11<sup>th</sup>. Compensation for funding in excess of €2m has been sought.

**Re-Start/Restart Plus Grants**

The Restart Grant Plus Grant Scheme closed as of 31<sup>st</sup> October, 2020. A total amount of €11.4m has been paid out to businesses in Kilkenny on behalf of the Department of Enterprise Trade and Employment.

**Rates Waiver**

As part of the support measures for businesses announced by Government during the year a waiver on commercial rates for the nine months to the end of December has been provided for eligible businesses. The waiver will take the form of a credit in lieu of rates. This Credit has been applied to eligible accounts and customers have been notified of same.

**Budget 2021**

The budget for 2021 was approved by Council on 27<sup>th</sup> November.

The compensation arising for Kilkenny is €8.6m. This leaves a balance of approximately €3m to be collected on commercial rates.
