# MINUTES OF ORDINARY COUNCIL MEETING HELD ON MONDAY, 23rd MARCH, 2020 AT 3.00 P.M.

Cathaoirleach CIIr Peter Cleere opened the meeting and advised that further to the agreement reached with all the members in proceeding to have the meeting, only 4 statutory items would be dealt with and all other items would be deferred to the next meeting.

It was proposed by CIIr Andrew McGuinness, seconded by CIIr David Fitzgerald and agreed by all that non-statutory items would be deferred to the next available meeting. It was further agreed that all members would be updated on the proceedings of this meeting.

# 2. (a) Housing & Other Disposal – Tithíocht & Díuscairt Eile

"That, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest by way of Lease of the property known as the former Castlecomer Courthouse, Kilkenny Street, Castlecomer, Co. Kilkenny, to Foroige National Youth Development Organisation, Block 12D, Joyce Way, Park West, Dublin 12, for a period of 5 years, at a rent of €1.00 per week, and with each party to be responsible for their own legal costs."

# (i) Part 8 Planning: Footpath - Ballyhale to Knocktopher

Mr Tim Butler presented the Chief Executive's Report on Part 8 Planning for the footpath from Ballyhale to Knocktopher. He advised that the proposed works were on public display. A number of submissions were received and these submissions have been considered and taken into account in the Chief Executive's report. Funding for the project has been approved under the Town & Village Renewal scheme. An allocation has also been included in the Council's Annual Roads Programme for 2020. Mr Butler advised that the Chief Executive is recommending that the Council proceed with the proposed works.

It was proposed by CIIr. Michael Doyle, seconded by CIIr. David Fitzgerald and agreed:

"We the members of Kilkenny County Council approves Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, as amended, for the Ballyhale to Knocktopher Footpath, as circulated."

# (i) Approve Overdraft of €20 million for 2020

Mr Martin Prendiville stated that due to the current crisis there is a necessity to increase our current overdraft approved in the sum of  $\in$  13m to  $\in$  20m. There will be a severe strain on the Council's finances due to the unfolding events of COVID-19 with businesses closing and people losing their jobs. He gave an overview on the following:

- Current cash balance
- Weekly expenditure on Payroll & Payments
- Affect on collection of Rates, Rents & Hosing Loans
- Deferral of payment of rates
- Ongoing capital commitments on existing contracts
- Staff resources have been dedicated to deal with all our debtors and there are adjustments being made to payments of rates, rents etc
- Review of Budget 2020 will be required
- Seeking subvention from the Government
- Other bodies supported by the Council are also seeking assistance.

Contributions were received from CIIrs M Brett, A McGuinness, T Breathnach, D Fitzgerald, F Doherty and E Aylward. Members supported the increase in the overdraft. Queries were raised on the following:

- Priority of Council should be to assist people in financial difficulties due to loss of income, losing jobs etc.
- Parking Charges/Fines should not be implemented at this time
- Early review of 2020 Budget
- Is € 20m sufficient, has approval of Bank been received

Mr Prendiville responded to the queries raised by the members. He advised that staff are dealing with a lot of calls from the public who have lost jobs etc. Revised payment arrangements are being put in place immediately. Every support is being given by our staff at this difficult time for people. There will be a necessity to review the Budget for 2020 at a later stage. Discussions have taken place with the Bank and the Department in relation to the increase in the overdraft. The evolving financial situation will be kept under review.

It was proposed by CIIr. Martin Brett, seconded by CIIr. Andrew McGuinness and agreed:

"That subject to the sanction of the Minister for the Department of Housing, Planning and Local Government, Kilkenny County Council hereby approves increase to overdraft borrowings by  $\in$ 7,000,000 to a maximum amount of  $\in$ 20,000,000 for the full year ending 31st December, 2020."

# (ii) Raising of Loan of €5 million from Housing Finance Agency.

Mr Martin Prendiville advised that members approval is required to raise a loan of  $\in$  5m from the Housing Finance Agency for the purpose of lending to approved housing loan applicants. The last approval was in 2018 for  $\in$  5m and to date  $\in$  4.8 m has been drawn down. The loan approval will allow the Council to lend in 2020 and 2021 depending on the number of approved applications.

It was proposed by CIIr. Martin Brett, seconded by CIIr. Tomas Breathnach and agreed:

"That Kilkenny County Council hereby approves the raising of a loan of five million Euro (€5,000,000) from the Housing Finance Agency plc for any purpose authorised under the Housing Acts".
