5. **Fógra Foriarratais in ainm an Comh. Peter ‘Chap’ Cleere, dar dáta 4 Aibreán, 2016.
Notice of Motion in the name of Cllr. Peter ‘Chap’ Cleere received 4th April, 2016:**

“That this Municipal District would seek immediate funding from the department of transport to ensure that all local roads in Kilkenny -Local Primary (LP), Local Secondary (LS) and Local Tertiary (LT) have adequate and sufficient numbering. The Roads Act 1993 gives local authorities the duty to "assign a number or other identifying mark to each local road in respect of which it has responsibility."

6. **Fógra Foriarratais in ainm an Comh. Malcolm Noonan, dar dáta 8 Aibreán, 2016.
Notice of Motion in the name of Cllr. Malcolm Noonan received 8th April, 2016:**

"That Kilkenny Municipal District Council would initiate a process to re-design and revitalise the Parade and Gravel (Mayor's) Walk. This would include seating accommodation of an inter-generational amenity area, accommodation of a performance area for concerts and accommodation of further cycle and motorcycle parking".

7. **Fógra Foriarratais in ainm an Comh. Michael Doyle, dar dáta 27 Aibreán, 2016.
Notice of Motion in the name of Cllr. Michael Doyle received 27th April, 2016:**

“That this municipal council would provide pedestrian crossings for both the Rower National School on the R705 and Inistioge National School on the R700, this will provide a safe crossing for parents and children on these two busy roads.”

8. **Fógra Foriarratais in ainm an Comh. Peter ‘Chap’ Cleere, dar dáta 15 Aibreán, 2016.
Notice of Motion in the name of Cllr. Peter ‘Chap’ Cleere received 15th April, 2016:**

"That this municipal district would investigate and complete a full traffic management plan for the town of Graiguenamanagh and bring forward proposals and options for implementation once full consultation with the local community has taken place."

9. **Fógra Foriarratais in ainm an Comh. Malcolm Noonan, dar dáta 3 Bealtaine, 2016.
Notice of Motion in the name of Cllr. Malcolm Noonan received 3rd May, 2016:**

“That members of Kilkenny Municipal District Council request Kilkenny County Council to consider the introduction of a single speed limit consistent with speed limits on connecting sections of road at the N79 road in its review of speed limits in the County. This would require the reduction in the speed limit between Shellumsrath to Tenny Park from 80kmph to 60kmph in order to improve general road safety in the area. This motion recognises that the guidelines on consistency in speed limits for National Roads is fundamentally flawed in this case as it fails to recognise (a) this section of road contains a substantial number of residential developments and (b) reducing the speed limit will configure speeds with connecting sections of road in this area.”
