

**MINUTES OF THE MAY MEETING OF THE MUNICIPAL DISTRICT OF CASTLECOMER HELD ON MONDAY, 15<sup>TH</sup> MAY 2023 AT 11AM IN THE COUNCIL CHAMBER, COUNTY HALL, JOHN STREET, KILKENNY**

**1. Confirmation of Minutes of:**

**(a) April Ordinary Meeting held on 17<sup>th</sup> April 2023**

The minutes were proposed by Cllr Pat Fitzpatrick, seconded by Cllr Michael McCarthy and agreed.

**2. Consideration of Reports and Recommendations:**

**(a) Broadband**

Mr Steve Coverdale updated members on Broadband related matters in North Kilkenny:

- Rollout status per Kilkenny Deployment Area (DA) provided.
- Update on NBI work ongoing.
- Details of how to keep up to date with NBI provided.
- Castlecomer - Cellnex still waiting for site owners to sign agreement.
- Urlingford - Bank of Ireland Site – financial feasibility stopped 500Mb connections. Development of site had ‘stalled’, but now progressing and will order the 150Mb connection to get services started.
- Cellnex granted a S254 licence for telecoms pole in Urlingford in September 2021 – still waiting for ESB connection to monopole.
- Cellnex looking at a potential of a larger site probably adjacent to the M8 during 2022 - no further progress on other possible sites.

Members thanked Mr Coverdale for the work completed and acknowledged what has been achieved.

**3. Business prescribed by Statute, Standing Orders or Resolutions of the Municipal District for transaction at such Meeting**

**(a) Extinguishment of Public Right of Way – Grange Lower, Goresbridge**

It was proposed by Cllr Pat Fitzpatrick, seconded by Cllr Denis Hynes and agreed that the Municipal District of Castlecomer hereby approve of the proposal to extinguish the public right of way at County Road number L6688 in the townland of Grange Lower, Goresbridge with an approximate length of 512 metres.

**Safety Improvement Works at Kanesbridge**

Cllr Pat Fitzpatrick raised concern regarding junction safety at Kanesbridge Cross Roads. Cllr John Brennan concurred with concerns raised.

Following discussion, Mr Philippe Beubry confirmed that he would include an application under the 2024 Low Cost Accident Scheme for improvement works at this location and in the interim 4 ‘Slow’ road markings would be provided.
