(a) September Ordinary Meeting held on 18th December 2024

2. Consideration of Reports and Recommendations:

(a) Castlecomer Settlement Plan – Caitriona O’Sullivan

Ms. Caitriona O’Sullivan gave an update to the members on the preparation of the Castlecomer Settlement Plan. Pre-draft public consultation has been undertaken. Main concerns related to water supply and traffic. Director will be preparing a report on the outcome of the public consultation.

The members thanked Caitriona for the work carried out.

(b) Ballyragget Masterplan – Arlene O’Connor

Ms Arlene O’Connor updated the members on the Ballyragget Masterplan and circulated the Directors report on the submissions received regarding the draft plan.

It is hoped that the plan will be published before the year end. It was agreed to put the item on the agenda for adoption at the next meeting.

The members thanked Arlene and her team. They also thanked the members of the community for partaking in the consultation process.

(c) Winter Maintenance Programme – Paraic Butler

Mr Paraic Butler presented the members with the Winter Maintenance Programme and explained how roads were prioritised under the plan.

Cllr Mary Hilda asked that the members be given an update on the agreement with the IFA to assist during severe weather. She also requested that members of the public who provided their own grit during severe weather would have their supplies replaced as they were providing a service to the public.

Cllr John Brennan asked that a letter be written to the Minister of Agriculture in relation to funding for the removal of diseased ash trees from the roadside.

(d) Parks Dept Update – Frank Stafford

Mr Frank Stafford gave an update to the members on the completed and ongoing projects in the region. Funding of over €590k has been provided to playground enhancements in 2023 and 2024.

Over €1.6m has been provided under the Outdoor Recreation Infrastructure Scheme 2021-2024.

Cllr Pat Fitzpatrick had requested this update and congratulated Frank and his team for the great work carried out. Cllr Mary Hilda Kavanagh requested that a press release be issued highlighting the positive work carried out.

The members thanked Frank and his team.
