**14(24): Proposed by Cllr. Seán O'hArgáin.**

“That Kilkenny Municipal District of Kilkenny County Council will seek a meeting with Transport for Ireland to discuss the expansion of Kilkenny City’s Bus Service, including the following priorities:

1. An expansion of the number of routes in the service to include more areas of the city.
2. That these services would include pick-up and drop-off facilities for residents of the Hebron Park/Kieran's Crescent/Millennium Court area and Seville Lawns/Margaret's Field areas and other residential areas, where residents are currently forced to walk over a kilometre to access the existing routes.
3. That these services would also service important retail and employment areas, including Kilkenny Retail Park and Purcellsinch Business Park.
4. That these services would service medical facilities at Kilcreene Orthopaedic Hospital and nursing homes including Archersrath and Drakelands nursing homes."

**15(24): Proposed by Cllr. Seán O'hArgáin.**

"In the light of additional and welcome housing development in the environs of Kennyswell Road and the existing traffic difficulties in the area, that Kilkenny Municipal District demand an urgent solution to the need for safe traffic management, including parking, adjacent to Kenny's Well itself and that this arrangement will involve consultation with all the residents of the area."

1. "That a review & plan for putting in place of traffic calming be undertaken at following locations.(Bohernatounish Road, Sycamore Drive & Woodbine Ave).
2. That an up-to-date position regarding the refurbishment / opening of the historic Jail Cells at Courthouse in parliament street for tourism purposes be addressed as part of the Medieval Mile. "
