## **Privacy Notice UcanACT**

Urban ACTion for cancer prevention (UcanACT): adult and senior citizens practice physical activity within public urban green spaces to prevent cancer diseases". The project is an intersectoral initiative, joining together physiotherapists, local authorities, non-profit organization, higher education and research institutions from Belgium, Germany, Spain, Italy and Ireland. The overall objective of the project is: to engage adult and senior citizens to practice physical activity (PA) and contribute to the EU policies, aimed at encouraging the participation of EU citizens in Physical Activity within public Green Spaces

The target groups for the UcanACT initiative includes Citizens over the age of 50 living in **Kilkenny City or living within 10 kilometres of Kilkenny City:** 

- 1) Citizens > 50 years of age living with cancer
- 2) Citizens  $\geq$  50 years of age in recovery from cancer or had a previous diagnosis of cancer in the past
- 3) Citizens > 50 years of age who do not have cancer or never had a cancer diagnosis (without cancer disease)

Kilkenny County Council will be the controller of your personal data processed as part of the UcanACT Erasmus+ programme. Therefore, any reference to 'we' 'us' or 'our' refers to Kilkenny County Council, unless stated otherwise.

This Privacy Notice provides information about:

1) how we will be using your data collected by Kilkenny County Council for the UcanACT questionnaire

- 2) how your data collected by Kilkenny County Council to conduct research as part of the UcanACt project
- 3) what your data protection rights are as a UcanACT participant

## Who will access your data?

The UcanACT Questionnaire is being delivered by Kilkenny County Council in partnership with The University of Seville, the data processor, who are conducting research and evaluation on the UcanACT project.

## What data are we collecting?

As part of your UcanACT questionnaire completion, we collect the following types of personal data:

- your name
- your email address and phone number
- your age
- your gender
- your Townland
- your height & weight

We also collect the following special categories of data for UcanACT:

- Your level of weekly exercise in the past 7 days (type, frequency time)
- Information on medical history, presence of medical conditions and
  Information on health conditions that may impact participation in physical activity
- History of cancer (if any) and stage of disease (treatment, active, re-mission, presence of symptoms)
- Health & Wellbeing and Social factors Barriers that motivate or limit participation in physical activity in public urban green spaces
- Environmental Influences or barriers for participating in physical activity in Public Urban Green Spaces
- Communications of Health information i.e. preferred method of receiving information on health and wellbeing

As part of UcanACT - Kilkenny County Council will not share any personal data (name, email, phone number address) that identifies you with any project partner or third party. Your personal information will be anonymized by Kilkenny County Council prior to sharing the questionnaire results with the University of Seville, the data processor, who are conducting research and evaluation on the UcanACT project.

## Why are we collecting your data?

Kilkenny County Council are collecting your data for the following purposes:

- 1. To explore any existing factors (health, social, environmental), barriers, motivators and opportunities that can influence participation in physical activity in green spaces for senior citizens. This information will inform a research needs analysis/evaluation and polices such as a Citizen Engagement Strategy on how stakeholders can influence and motivate senior citizens to participate in physical activity in Public Urban Green Spaces
- 2. To invite you to attend and register for focus groups in January 2023 to explore more information about the needs and barriers for participation in exercise in Public Urban Green Spaces
- 3. To invite you to participate in future elements of the project e.g. Physical Activity Sessions that will be rolled-out by physiotherapists in Kilkenny
- 4. To receive communications/information on the UcanACT project e.g. webinars, leaflets, policies, reports.

## Legal Bases for processing personal data

We are processing your personal data as part of this sign up based on your consent under Article 6(1)(a).

We are processing your special category data based on your explicit consent under Article 9(2)(a).

You are not required to consent to the processing of your personal data under this Questionnaire. However, where you do not consent you will be unable to participate in further elements of the UcanACT project (focus groups)

### Who are we sharing your personal data with?

Your data collected and stored upon consent to Kilkenny County Council and non-personal data will be shared with The University of Seville. who are conducting research and evaluation on the UcanACT project. This will inform the needs analysis of the UcanACt project and research objectives.

Kilkenny County Council will not share any personal data (name, email, phone number address) that identifies you with any project partner or third party. Your personal information will be anonymized by Kilkenny County Council prior to sharing the questionnaire results with the University of Seville.

## **Third Country Data Transfers**

Your personal data will be transferred to the University of Sevilla, Spain, once you complete and consent to the UcanACT questionnaire. The research and evaluation of your personal data by The University of Sevilla will also take place in Spain. The transfer of your personal data from Ireland to Spain is appropriately safeguarded by the European Commission's adequacy decision in respect of Spain's data protection laws.

We have taken all precautions to ensure that the necessary data protection security measures are in place for any transfer of your data under the UcanACt project

## How long will we retain your data?

Kilkenny County Council, University of Seville, will retain your data collected under the questionnaire for the duration of 5 years after the project is completed, which will be June 2030

## **Your Rights:**

You have rights in respect of your data that we are processing as part of UcanACT. Those rights include the following:

• The right to access a copy of your personal data

- The right to rectification
- The right to erasure
- The right to restriction of processing
- The right to data portability
- The right to object processing
- The right to withdraw consent
- The right to lodge a complaint with the Irish Data Protection Commission

Where we are processing data based on your consent, you have the right to **withdraw consent** at any time.
